The AGBC is organized as a Club (*Verein*), and we follow German law for club membership (*Vereinsgesetz*) as outlined in our AGBC Munich Chapter bylaws (*Satzung*).

Membership begins at the start of the month of acceptance. The membership fee is payable in advance and covers the current calendar year or the remainder thereof. If membership commences in the course of the calendar year, the membership fee is payable by the first day of the month following reception of the written membership approval.

Membership renews automatically at the start of each following year, unless it is cancelled by written notice at least one month before the end of the current calendar year, as required by the German *Vereinsgesetz*. In exceptional instances, membership ends for Individual members in the case of fatality or for a Corporate member in the case its legal entity is officially dissolved.
